Deposit	Amount Due	Due Date
Initial Deposit	10% of Group Space	Within 30 Days of Acceptance
Second Deposit	1/3 of Group Space	150 Days Prior
Third Deposit	1/3 of Group Space	120 Days Prior
Final Payment	Balance	60 Days Prior

As an alternative to cash deposits, group may choose to provide LOC with three equal payments at 105, 75 and 45 days prior.

Failure to make any payment on time or in the required amount will result in automatic reduction of the cabin block.

Carnival reserves the right to take back the portion of cabins not properly deposited for re-sale to the general public and Purchaser will hold only those cabins for which payment has been received.
