Note: Each amenity listed below has a "point value". Match the points offered to you with your group booking with the amenities listed below to create a customized amenity program. A minimum of 8 staterooms required to receive CAP points. You can select and/or change your CAP Amenities up until Final Payment.

WHAT YOU NEED TO KNOW

The amenities described in this program are applicable to group bookings only. A minimum of 8 staterooms is required for a group booking. *Some amenities require higher minimums. This is a capacity controlled program by ship and sail date and may be withdrawn at any time. These amenities are for full fare paying guests and exclude third and fourth guests in a stateroom.

ROYAL RECOGNITION GIFTS

Sparkling Wine/Wine

One bottle of Aussiere's red or white wine or Domaine Ste Michelle sparkling wine will be delivered to guests' staterooms but may be carried to the dining room for consumption. No corkage fee applies; limited to one bottle per stateroom; available for delivery on day one of the cruise; wine will not be delivered to staterooms occupied solely by minors.

Fruit Plate

Seasonal fruits artfully arranged on a plate. Delivered on day one of the cruise.

Slippers (His and Hers)

One pair of men and one pair of ladies terry cotton slippers delivered to each stateroom. One size for each.

Onboard Credit

Choice of \$25 USD, \$50 USD, \$75 USD or \$100 USD CAP onboard credit per stateroom. Onboard credit is limited to \$100 USD maximum per stateroom and to ships that operate in US currency. Onboard credits are non-transferable and are only applicable to group sailed staterooms. Onboard credits are non-refundable and may not be redeemed for cash.

High Rollers Package

Guests will receive a casino credit voucher for \$25 per stateroom, redeemable in Casino Royale.® Must be 18 years or older to receive this amenity. (21 years or older for all Alaska itineraries.)

Cocktail Reception*

Group guests will enjoy a one hour cocktail reception with an open bar (house/call brand liquors) and an option to add hot and cold canapes. To qualify for this amenity, a minimum of 25 staterooms is required for cruises of 6 nights and longer and a 50 stateroom minimum is required for cruises of 5 nights or less. Limited to one CAP reception per group sailing. Night one CAP receptions require approval.

Royal Signature Package

Unique collection of gourmet treats including yogurt covered raisins, cookies, biscotti and a Crown and Anchor box filled with chocolate covered dried cherries.

Wine and Cheese Tray

Assorted cheese with crackers artfully arranged on a tray. Served with choice of Solaire by Robert Mondavi Cabernet Sauvignon, Castle Rock Chardonnay, or Beringer White Zinfandel. Wine selection must be made at time of booking. If wine is consumed in dining room, corkage fee applies.

Delicious Cupcakes

Four cupcakes; choice of vanilla or red velvet.

Chocolate Covered Pretzels

Oversized milk chocolate covered pretzels sprinkled with white chocolate chips. Approximately 5 per package.

ADDITIONAL BENEFITS

Marketing Fund

Use Marketing Funds to promote your group. Marketing Funds are deducted from the invoice at final payment and are limited to one payout per group per stateroom. Marketing Funds are paid as an override commission on the net cruise revenue.

Master Account Onboard Credit

Choice of \$12.50 USD or \$25.00 USD per stateroom Master Account Onboard Credit to be utilized by the Group Leader/Organization for additional group onboard spend. Master accounts are non-transferable and are only applicable to sailed group staterooms. Onboard credits are non-refundable and may not be redeemed for cash.

Accelerated Tour Conductors (T.C.) - Credits

Reduce your tour conductor requirements to as low as 1 for 10 from the standard 1 for 16 ratio. Tour Conductor credits must be booked and sail as part of the group or be paid as a Marketing Fund post sailing

One and Two Category Upgrades

Upgrades are applicable from categories Q-K and I-F. Balcony upgrades are applicable on Radiance class, Voyager class and Freedom class ships only from categories D1-D3 & E1-E3 (excluding family stateroom). Upgrades are not available from interior to outside or outside to balcony accommodations. One and two category upgrades are subject to availability of staterooms in the categories to which the upgrades are requested. If upgrade is not available, you may choose another amenity.

Guaranteed Outside Travel Host Stateroom (Cruise Only)

One confirmed outside stateroom to be used by travel host or staff priced at \$50.00 per person per day, limited to double occupancy, governmental taxes and fees are additional. Stateroom to be assigned by Royal Caribbean at time of amenity selection and is based on inventory availability. Not applicable towards cruisetour packages or with air purchased through Royal Caribbean.

Group Leader Suite Upgrade*

Upgrade is available from balcony to suite and is provided at the time group reaches a minimum of 20 booked staterooms. Stateroom to be assigned by Royal Caribbean at time of amenity selection and is based on inventory availability. If upgrade is not available, you may choose another amenity.

NOTE: All Royal Recognition Gifts are delivered at turndown on second evening & may not be doubled in quantity, unless stated differently above.

Terms and Conditions: Final selections for the use of CAP points must be made by 70 days to sailing. CAP may not be reassigned after the final assignment date. The assignment of CAP may be requested once the group reaches eight booked staterooms or when the minimum stateroom requirement is met. Minimum stateroom requirement may be less than eight staterooms when applying points towards a reduced TC ratio. Some amenities require higher minimums. If the group's stateroom count falls below the minimum required, all CAP amenities will be forfeited with the exception of Royal Recognition Gifts. Groups can receive up to 3 additional CruiseTour GAP points if cruise points are offered on the cruise. If a cruise has zero GAP points, then no GAP points will be assigned to the CruiseTour group.
